
In the past, SAWCo has provided help to some of its shareholders when they have received large water bills after they have repaired water leaks on their property. SAWCo's newly installed water meters offer shareholders the ability to monitor their water usage and receive alerts of water leaks on their property. We encourage all our domestic shareholders (the San Antonio Heights) to sign up for Waterscope in order to access this important information about their water consumption.

WaterScope can be accessed online through a web browser (Safari, Firefox, etc.) at https://www.waterscope.us/.

Registering your water meter with WaterScope requires your account number and the meter number (titled VN number in Waterscope). This information can be found on your water bill. Once registered, you can download the App to your cell phone and/or tablet, simply search the App store for 'WaterScope' and follow the prompts.
