

# Water Efficiency Corner



We have recently partnered up with American Leak Detection (ALD) to provide leak detection to customers that appear to have a leak(s) on their property. ALD has the most current and up to date equipment to locate the leaks on your property indoors and outdoors. If you have been contacted by our office or suspect a leak on your property and have exhausted all efforts to locate the leak, please contact our office to sign up for leak detection thru American Leak Detection. The Water Company's leak de-

tection program offers payment for leak detection and sharing in a portion of the cost of the repairs with the customer. Please note that the program runs until the limited funds are exhausted.

## Hi Tech Flo Device to Monitor Indoor Water Supply

The Water Company can make available a "Flo" water security management system that is professionally installed on your main water supply line through American Leak Detection (ALD). This system uses an IOS or Android app which continually monitors your home's water flow, pressure, temperature and detects undesired water flow or abnormalities. The system proactively detects indoor leaks and can shut off your water supply automatically in response to a pipe burst or flooding and alerts you via email or app message by text or phone call. More info is available at meetflo.com. If you are interested in this device, call our office at (909) 982-4107 and we can connect you with ALD. The cost for the device with installation is approximately \$650 which will be the responsibility of the shareholder.
